Greetings and warm wishes for a prosperous, productive, and personally rewarding 2020! The New Year is upon us, but as always, NCJW Long Beach has been busy at work since last June, when we began the planning for our year that runs from July 1 through June 30. By now, you are aware that we are holding a vote on an amended name for our Section: National Council of Jewish Women Greater Long Beach and West Orange County Section, National Council of Jewish Women, Inc. Hopefully you have called, emailed or sent in your vote before our deadline of December 31, 2019. If you have not yet voted, please do so right away. We cannot proceed with our state application without a majority vote of yes by our entire membership. Now that a third of our membership lives beyond the city of Long Beach proper, it makes a great deal of sense to reflect that as well as to reflect our expanded outreach (see the list below).

Some highlights of the accomplishments and activities we have under our collective belt since July 1 are:

- ▶ Voter registration drives at both Long Beach Community College campuses, Orange Coast College in Costa Mesa, and Golden West in Huntington Beach
- A successful and enjoyable Fall Membership event Sing Shalom! luncheon with the inimitable Cantor Nancy Linder
- ▶ Pastry and Politics: programs featuring outstanding programs in September (Human Trafficking: It Happens in Our Backyard) and November (Losing Roe: What Would This Mean for California?)
- Tributes to our partner Long Beach Immigrant Rights Coalition and to BeJeweled! honoring our dear Barbara Alpert (z"l) and the Alpert family, along with the 20th Anniversary of the Alpert Jewish Community Center
- Two Hug Packing sessions (August and November) providing 300 filled backpacks for children entering the foster care system (in support of LA County DCFS, Lakewood office)
- Our Tea "For the Child" in November that provided the trimmings for Thanksgiving dinner for a significant number of families in need served by this agency, whose clients include abused and neglected children and their families. We also collected gently used books for this agency over the summer.
- Chanukah donations of toys for clients of For the Child at our always fun Chanukah Potluck, with our unique artist-designed NCJW "Breaking the Glass Ceiling" pendants and pins newly available for purchase

OUR WOMAN OF VISION 2020 ADVOCATE PAR EXCELLENCE IS SHERRI SOBEL

NCJW Long Beach's new-found energy in many areas of advocacy in Greater Long Beach and West Orange County finds its impetus in the advocacy portfolios that Judge Sherri Sobel created and implemented as our advocacy co-chair. NCJW Long Beach now has official representation as a member of nine local and area coalitions as well as partnerships with several others, a result that is certainly attributable to her dedication to and work for our organization. Sherri has promoted far and wide the mission and vision of NCJW Long Beach/Serving Greater Long Beach and West Orange County.

Sherri Sobel has been teaching, "speeching", and preaching about children and families since 1965. She has taught English in an inner city high school, worked on campaigns for women candidates, and voting rights for elections. At the age of thirty seven she started law school, finished and passed the bar at forty. She immediately started working in child welfare, and has been there, bench and bar ever since. She is an expert in education for foster children, and has been an expert advisor for ten bench guides and taught at Judicial College. In 2013 she retired, and immediately met the "Lindi" (Calderón z"l and Fox) and joined National Council of Jewish Women. She co-chaired the advocacy committee for two years, then moved to Executive Vice President. She continues to work on issues around education, reproductive rights, and legislation, and has been recently trained by NCJW Inc.

as a spokesperson for the national NCJW initiative Benchmark, whose objective is to educate about the importance of the judiciary in our communities and in our society. She also attends OLLI classes, where she is writing about child welfare issues, enjoys book clubs, and ushers at Musical Theatre West with her husband, Craig. She has just begun teaching a mindfulness and mentoring class in an eighth grade Catholic class in Compton.

Her finest work, however, is her family, her children, and her perfect grandson, Bennet.

2020 HANNAH G. SOLOMON AWARD

NCJW Long Beach Section/Serving Greater Long Beach and West Orange County is proud to announce that our Hannah G. Solomon award for 2020 will be presented at our Charter Day Luncheon to Congressman Alan Lowenthal. Throughout his long career of public service, Representative Lowenthal has embraced a human rights and dignity agenda that reflects the priorities of NCJW. He has long been a friend of our organization and shares our goals and values.

Representative Alan Lowenthal is serving his 4th term in Congress, representing California's 47th district, which includes Long Beach and parts of Orange County. He serves on both the House Natural Resources Committee (HNRC) and the House Transportation and Infrastructure Committee (T&I).

He earned his bachelor's degree from Hobart and William Smith Colleges and his PhD. from the Ohio State University, before teaching psychology at California State University, Long Beach for nearly three decades.

Congressman Lowenthal served two terms on the Long Beach City Council, three terms as a California Assemblyman, and two terms as a California State Senator before being elected to Congress,. He is widely regarded as a leader on environmental, transportation, human rights, and education issues.

Representing one of the most ethnically diverse districts in the nation, Congressman Lowenthal has championed human rights in Congress, not just at home, but throughout the world. He has also brought his strong support for LGBT rights to Washington where he became the first Congress member to permanently fly the Pride flag outside his office. His support for women, family and childrens' issues has been constant.

In addition, he has continued his long history of fighting for environmental protections, with a new mission to bring the issue of climate change to the front in Congress as chair of the more than 60-member Safe Climate Caucus.

We look forward to honoring Congressman Lowenthal.

But none have had the impact on the Jewish future in the Long Beach area as the late Barbara Alpert and her husband Ray. Their business started at a time when California was experiencing dynamic growth and, over many years, became extremely successful. The primary focus of their philanthropy became the growth and sustainability of the Jewish community of greater Long Beach. They founded and supported numerous programs to do just that, the most visible being their major donation to the new Jewish Community Center which now bears their name. Among their other donations is the Cal State Long Beach Chair of Jewish Studies, Temple Israel, the California Conference for Equality and Justice, and the AJCC New Leadership Program. Ongoing donations have supported Sharon-Carmel Hadassah as well as Long Beach Section of NCJW and other groups. Barbara was a Life member of NCJW, as are her daughters Teri, and Nancy, and a daughter in law and granddaughters. Barbara was named the Hannah G. Solomon award winner in 2015. Barbara Alpert has been an inspiration to the Jewish community and has left a life-long legacy to all of us.

January is now recognized as Human Trafficking Awareness Month. On Saturday, Jan. 25, 2020 the Long Beach Human Trafficking Task Force (LBHTTF), founded in 2012, will present its fifth annual Youth Empowerment Safety Symposium (YESS) at the Salvation Army, 3000 Long Beach Blvd, Long Beach 90807. This free event, which runs from 10 a.m. to 2 p.m., will include workshops and presentations to inform youngsters and their caregivers about existing dangers and how to avoid them, as well as a great display of agencies working to prevent this modern day slavery and to help survivors. NCJW Long Beach has been a member of this Task Force since 2014 and provides some of the volunteers needed to make this day a success. Last year NCJW staffed part of the sign in and information table, but assignments vary.

LBHTTF core member Virginia Zart said art displays and special performances will add an element of fun to the day, along with food such as hamburgers and hot dogs and pizza, all of which are donated. Youth leadership groups will offer rallies and stage shows. Last year, 300 people attended the symposium and a similar number of visitors are expected this year.

"This event gives them a place to learn, have fun, and see how much support there is in our own community to help and empower them," Zart said. Appropriate for ages 13 and over.

WHY: To get inspired, to make change happen (voting on new board and bylaws and revising resolutions for 2020-2023), to learn something new (great workshops and celebrity speakers), and to cultivate connections with new CEO Sheila Katz and other fierce feminists from around the country who turn passion into action

HOW: Anyone can attend and is encouraged to do so. NCJW Long Beach/Serving Greater Long Beach and West Orange County will be given a specific number of voting delegates. Those who wish to be delegates need to submit a request to the NCJW Long Beach Nominating Committee that includes a commitment to a future leadership role. Those chosen will qualify for a subsidy from our Section and register for the full conference ticket. This year there is also a Shabbat ticket that begins at 2:30 pm Friday, April 24 through the rest of the Convention, ending at 10:00 pm Saturday, April 25 for those who are not voting delegates and wish to skip the business meetings. Registration fees therefore vary. Registration will begin soon! Early registration (with a lesser fee) ends January 20, 2020, and it is highly recommended to register by that date, particularly if desiring a subsidy. Hotel arrangements are made separately on your own but if you are a voting delegate and/or will be receiving a subsidy, we expect you will request double room occupancy.

PROCESS: First, check out the full Conference description and segments on the National website www.ncjw.org. Click on the Convention button at the top, as well as the multiple segment descriptions on the left. Anyone may register to attend. However, preference for Section subsidies will be given to our voting delegates, those who currently have a leadership role and/or those who commit to a future leadership role. The year 2020 marks the 100th anniversary for women earning the right to vote. Absolutely a cause to celebrate! PASTRY & POLITICS ON REPRODUCTIVE RIGHTS

Since its founding in 1893, NCJW has worked steadfastly to bring reproductive freedom to women and their families. While we have seen much progress over the last 100 years, including the Roe v. Wade Supreme Court ruling in 1972, in recent decades, and especially in the past few years, women's fundamental rights to abortion and contraceptive health services have been attacked in a multitude of lawsuits and regulations across the country. On November 4 an audience of about 50 heard from three distinguished speakers about the history of reproductive freedom, the current state of reproductive health care services, and some specifics about what's happening locally.

Our keynote speaker was Professor Michele Goodwin, who is the founder and director of the Center for Biotechnology and Global Health Policy at UC Irvine. She began our evening by sharing some historical perspective. She drew a line from how African-American women were demeaned and abused as slaves in this country to reproductive justice issues today. Abortion had been a common and legal tool of midwives for



millennia, including under slavery. With the advent of the new science of Obstetrics & Gynecology, male doctors replaced midwives and stopped doing abortions, making them illegal. Roe v. Wade changed this, but in recent years new anti-abortion laws have multiplied across the country.

Professor Goodwin explained how these laws are being challenged in the courts, including in the Supreme Court. But with the recent additions to the Supreme Court, restrictive laws now have more chance of being upheld. While we are protected in California, obviously rulings at the Federal level can affect us. We must remain vigilant and involved.

Our next speaker was Betha Schnelle, the Chief Operating Officer of Planned Parenthood of Orange and San Bernardino Counties. Betha explained that only 5% of the visits to their clinics last year were for abortion services, which helped the audience understand that Planned Parenthood provides primarily non-abortion, comprehensive health care services to women and men. While the rate of abortions is declining overall in the U.S., she explained that low income women and women of color are disproportionately represented among those seeking abortions.

Betha noted that between 2011 and 2017, 33 states have passed 480 laws restricting abortions. As a result, in certain parts of the country, women must travel long distances from their homes to the nearest abortion provider. In response, Planned Parenthood has developed an online national search tool for patients, enabling them to find a Planned Parenthood clinic near them. In addition, Planned Parenthood clinics in states where abortion access remains, such as California, are developing partnerships with clinics in states with restrictions. Additional funding will be needed to recruit, hire, and train new staff to support this effort. Planned Parenthood is also coordinating logistical support for patients who may have to travel distances to receive abortion services. This could lead to a future opportunity for NCJW members to become "patient navigators" who help provide such support to traveling patients.

The Honorable Judge Lynne Riddle, a retired Federal judge, was our final speaker of the evening. She discussed the California Healthy Youth Act, which requires six hours of sex education instruction both in middle school and high school. While this law was passed in 2003, there are compliance problems in a number of school districts throughout the state. In addition, there has been a chorus of criticism expressed by fearful and angry parents at various local school board meetings.

Judge Riddle suggested that the audience discover how the law is being implemented in our local schools. And she encouraged us to support our local school boards in providing this important part of a child's education. With more adequate sex education throughout our schools, teens will better understand their needs for comprehensive health care services, and perhaps the number of abortions will continue to decline. And this becomes yet another advocacy opportunity for NCJW members!
