NCJW Greater Long Beach and West Orange County has more than risen to the challenge by providing information, programs and opportunities to volunteer for our members. We joined with other Sections in California and across the country, to work with Vote Forward. Over 40 members wrote over 1,000 letters to low propensity voters to encourage them to vote. Another group of volunteers called every Section member to remind them to "make a plan" and vote in whatever manner felt best and safest for them. Deb Chankin and Janet Rosenblatt deserve kudos for their leadership in these efforts.

We dedicated much of our activity to the memory of Justice Ruth Bader Ginsburg and held a memorial gathering. We were led by Rabbi Heidi Cohen and seven members read from Justice Ginsburg's writings and opinions. We closed with a song and with each of the participants making a commitment in the "Chat". # RBG MEMORIAL

We all know that on the morning of Erev Rosh Hashanah, Justice Ruth Bader Ginsburg passed away. Many of us struggled with how to mourn and grieve amongst the partisan rhetoric that began bouncing around our newsfeeds.

NCJW, Inc. created a new website, <a href="www.courtsmatter.org">www.courtsmatter.org</a>, and #RuthsRevolution to be a clearinghouse for our progressive activism to "continue Justice Ginsburg's legacy by advocating for a fair, independent, and qualified judiciary." One item in Ruth's Revolution was a plan to Circle the Courthouse on Friday October 20 as a symbolic end to Shiva, as well as a shout-out regarding the judiciary.


On Wednesday, September 30, members of the Advocacy Committee met with President Barbara Shipnuck to discuss what the response of NCJW Greater Long Beach and West Orange County would be to National's campaign.

And on the morning of Friday, October 2, 2020, more than 60 members of the community came together for a Memorial Gathering via Zoom to remember and pay tribute to the late Justice Ruth Bader Ginsburg, z"l. The Gathering was planned and organized by Deborah Chankin, Natalie Swit, Cynthia Gordon, and Deb Lelchuk.

We shared a montage with photos from RBG's youth, her family, her friendship with the late Justice Antonin Scalia and much more, together with various readings that described her larger than life impact on the lives of women. It was all tied together by inspiring words and singing from our guest, Rabbi Heidi Cohen of HaNefesh.

Deborah Chankin read a poem translated from the Hebrew, Every Person Has a Name, by Zelda [last name unknown] {1914-1984}, followed by the Kaddish. Rabbi Cohen, singing I Have a Voice, by Elana Arian, brought tears to our eyes and commitment to our hearts. Attendees were asked to finish the sentence "I will...."---many pledged to vote, to fight injustice and to share their passion.

# **VOTING AND ELECTIONS NOVEMBER, 2020**

As you read this the election is upon us, but it has engaged your Advocacy committee for the past many months.

Most of you have voted by now, but if you or anyone you know has not yet voted, you can still turn in your mail-in ballot, vote and even register at any Vote Center. We do not recommend using the USPS in these last few days.

# Up until now:

- Over 40 volunteers from our Section participated in mailing more than 1000 Get Out the Vote (GOTV) letters to Florida voters. Together with other California sections, we sent more than 12,000 letters!
- Other volunteers worked through CLUE, a local progressive faith based coalition, to send GOTV postcards to North Long Beach.
- Still other volunteers placed GOTV phone calls to our members.
- And about 60 of you spent an evening with us on Zoom, learning about California ballot propositions from our partners at the League of Women Voters.

# LETTERS, PETITIONS, AND COMMENTS

he Advocacy Committee has been busy in the last several months signing letters and petitions on behalf of the Greater Long Beach and West Orange County Section on issues that correspond to our progressive agenda.

### JULY

• Submitted a comment written by Deborah Chankin opposing DHS proposed asylum regulations limiting scope of admissions, redefining persecution and social group and excluding gender as a basis for persecution.

# **AUGUST**

- Signed a letter supporting the Anti-Defamation League in its response to an anti-ADL campaign that published a laundry list of "tired, false and misleading statements about its 107+year history promoted by many of the same groups who have been pushing an anti-ADL agenda for years."
- Submitted a comment on Refugee Arrivals written by Sherri Sobel opposing a proposed federal regulation that would prohibit anyone who came from or passed through a country with Covid-19 from applying for asylum, in effect completely gutting the asylum process.
- Submitted a letter written by Sherri Sobel to Governor Newsom, supporting a California Budget Request of \$30 Million to protect Californians who are at risk for human trafficking abuse and mistreatment due to COVID-19. This increased funding is needed to ensure existing frameworks are expanded in response to the increased risks resulting from the COVID-19 pandemic.

### **SEPTEMBER**

- Emailed Governor Newsom in support of the C.R.I.S.E.S. ACT (AB 2054) which would create funding for community-based organizations to provide emergency response for people experiencing mental health crises, homelessness, intimate partner violence, and other emergencies. Ultimately, Governor Newsom did not sign this legislation.
- Submitted a comment to the Adelanto City Council in opposition to the expansion of the Adelanto Detention Center.

### **OCTOBER**

• Submitted a comment on another proposed rule related to asylum involving multiple proposals, some building upon previous immigration restrictions, others representing new attacks on asylum rights. The proposed rule includes imposition of a new deadline, a fee and an arbitrary 180-day deadline and restrictions on evidence.
